## Langley Federal Credit Union 12 Days of Langley Sweepstakes

## **OFFICIAL RULES**

NO PURCHASE, ENTRY FEE OR CREDIT CARD TRANSACTIONS, NECESSARY TO ENTER OR WIN. NON-PURCHASE ENTRIES AND PURCHASE ENTRIES HAVE AN EQUAL CHANCE OF WINNING. SWEEPSTAKES SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS. The Sweepstakes is open only to 1) a legal U.S. resident 18 years of age or older at time of entry, and 2) a Langley Federal Credit Union Member in good standing with an open Langley® VISA Credit or Debit Card, or members that have used the CashBack+ feature in Langley's Digital Banking or successfully referred a member who has met the criteria, excluding Langley® Platinum Business VISA Credit or Debit Card. Void where prohibited or otherwise restricted by law.

**SWEEPSTAKES PERIOD:** The Langley Federal Credit Union 12 Days of Langley Sweepstakes ("Sweepstakes") begins at 12:00:00 a.m. Eastern Time ("ET") on October 28, 2024 and ends at 11:59:59 p.m. ET on November 30, 2024 ("Sweepstakes Period"). The Sweepstakes consist of one entry period and twelve drawing periods. Drawing periods will occur between December 2, 2024 and December 17, 2024.

**HOW TO ENTER:** NO ACTUAL PURCHASE OR TRANSACTION IS REQUIRED to enter the Sweepstakes. Winner need not be present to win but must prove eligibility to receive prize. The odds of winning are dependent on the number of entries. There are two (2) ways to enter the Sweepstakes during the Sweepstakes Period. 1) Automatic Entry; and 2) U.S. Mail.

**Automatic Entry:** To participate, an eligible Langley® VISA Credit or Debit Card cardholder must have entered into the Langley Sweepstakes by 11:59:59 p.m. ET on November 30, 2024, to be eligible for entry. An eligible Langley® VISA Credit or Debit Card personal cardholder, in good standing, who uses his/her personal Langley® VISA Credit or Debit Card ("Eligible Card") will automatically receive one (1) Sweepstakes entry for one (1) qualified use of their eligible card, up to five (5) entries per day, per primary member number, during the Sweepstakes Period. If a primary member number has more than one (1) qualified eligible card, the maximum limit of five (5) automatic entries applies to the primary member number, not per eligible card. In the instance of a co-applicant cardholder, the automatic entries are added to the automatic primary cardholder entries for a maximum total of up to five (5) entries per primary member number. Cash advances, cash transactions and ATM transactions are not eligible. Refund/Return transactions are also excluded from eligible entries. Eligible Cards or card numbers that have been stolen, are fraudulent, tampered with or otherwise altered are not eligible for automatic entry. Entry will be deemed submitted by the primary person in whose name the Eligible Card used to enter the Sweepstakes was issued.

To be deemed eligible, all eligible transactions must have an account posting date that is prior to the end of the Sweepstakes Period. Qualifying transactions made on Saturdays, Sundays or

Holidays will count as entries when they post to the Credit Card account by 11:59:59 p.m. ET on November 30, 2024.

Members may also automatically receive one (1) Sweepstakes entry for one (1) qualified use of the CashBack+ feature in Langley's Digital Banking environment, up to five (5) entries per day, per primary member number, during the Sweepstakes Period. Eligible uses that are fraudulent, tampered with or otherwise altered are not eligible for automatic entry. Entries from CashBack+ uses can be combined with automatic entries from eligible Credit and Debit Card swipes for a total of ten (10) automatic entries per day.

Members who successfully refer members using Langley's member referral process, will also automatically receive an entry for every member who has met the criteria for membership. This offer applies to individuals who open a new personal checking account at Langley with 10 debit card transactions within the first 60 days of having the account OR any loan with a balance OR at least \$1,000 (aggregate total of savings accounts only) when a valid Referral Code is presented at the time of account opening. The new personal checking account must be the first account at Langley for the new member to be eligible for the offer. When referring a friend, each party may be aware that the referrer is a member of Langley. All measures to protect member-sensitive information and confidentiality apply. In addition, each party understands that failure to receive an account bonus may mean that a referred account did not meet the offer criteria outlined above and does not imply an account application was denied.

Any entries received on December 5, 2024 will be entered in the sweepstakes for the prizes drawn between December 6 – December 17, 2024. Entries received after close of business on December 6, 2024 will discarded and ineligible to enter. Each mail-in entry will count as one (1) daily entry to the sweepstakes and have an equal chance of winning. Limit five (5) entries per day, per household. One (1) entry per postmarked and stamped envelope will be accepted for each day of the entry period. No mechanical reproductions permitted. An eligible Langley member who uses his/her Langley® VISA Credit or Debit Card ("Eligible Card") attached to their Langley account, purchases a gift card via the CashBack+ feature in Digital Banking, or for each member who refers a new member that meets the criteria using the Langley® Member Referral system. Void where prohibited or otherwise restricted by law. All federal, state and local laws and regulations apply. Taxes, if any, are each winner's sole responsibility. **PRIZES:** Total of twelve (12) Prizes will be available to be awarded.

Total Value of all prizes to be awarded: \$3,574.74 Prizes will be available to pick-up at Langley Federal Credit Union Corporate Office, 721 Lakefront Commons, Suite 400, Newport News, VA. If winner is located outside the Hampton Roads area or unable to physically retrieve the prize, Langley Federal Credit Union may, in its sole determination, substitute any original prize for a VISA gift card of equivalent approximate retail value.

Any and all costs and expenses associated with prize acceptance are the sole responsibility of the Prize winners including all applicable federal, state, and local income taxes.
