## ACCOUNT DISCLOSURES

*Except as specifically described, the following disclosures apply to all of the accounts. All accounts described in this Truth-in-Savings Disclosure are share accounts.*

**1. RATE INFORMATION** — The annual percentage yield is a percentage rate that reflects the total amount of dividends to be paid on an account based on the dividend rate and frequency of compounding for an annual period. For Savings, High-Yield Savings, Money Market Savings, Platinum Money Market, Langley Saves, Holiday Savings, Money Market IRA, Platinum Checking, and MyDesign Savings accounts, the dividend rate and annual percentage yield may change monthly as determined by the Credit Union's Board of Directors. The dividend rates and annual percentage yields are the prospective rates and yields that the Credit Union anticipates paying for the applicable dividend period. The Money Market Savings, Platinum Money Market, and Money Market IRA accounts are tiered rate accounts. Once a particular range is met, the dividend rate and annual percentage yield for that balance range will apply to the full balance of your account. The Langley Saves and High-Yield Savings accounts are tiered rate accounts. Each dividend rate will apply only to that portion of the account balance within each balance range.

**2. MYDESIGN SAVINGS** — For MyDesign Savings accounts, you may qualify for a higher dividend rate and annual percentage yield if you meet the applicable minimum qualification requirements for the monthly qualification cycle. To meet the minimum qualification requirements, you must; a) have a

MyDesign Steady Saver or All-In Bundle primary checking account; b) be enrolled to receive E-statements; and c) make recurring online banking deposit. The monthly qualification cycle is defined as the first day of the calendar month to the last day of the calendar month. If you meet the minimum qualification requirements during the monthly qualification cycle, the first dividend rate and annual percentage yield listed for this account in the Rate Schedule will apply to your entire balance. If you do not meet all of the minimum qualification requirements during the monthly qualification cycle, the second dividend rate and annual percentage yield as listed in the Rate Schedule will apply to the entire balance in your account. MyDesign Savings accounts are only available to be serviced online. This means service for the account is delivered through a mobile app or desktop computer. The following ranges are restrictions on the amount of recurring online banking deposits; weekly \$10-\$100, biweekly \$20-\$200 and monthly \$50-\$500. ACH transfers are not allowed for this account type. Any ACH entry received for this account will be returned to the originating financial institution as a non-transaction account. As defined by Regulation D, a non-transaction account is one where transactions are either prohibited or subject to limitations. ATM access is not permitted, the account is limited to one withdrawal or transfer per month and is not available for overdraft transfers or automatic transfers to other accounts.

**3. HIGH YIELD SAVINGS** — For High Yield Savings accounts you may qualify for a higher dividend rate and annual percentage yield if you meet the applicable minimum qualification

requirements for the monthly qualification cycle. To meet the minimum qualification requirements, you must; a) be enrolled to receive E-statement and b) only make up to one (1) withdrawal. The monthly qualification cycle is defined as the first day of the calendar month to the last day of the calendar month. If you meet the minimum qualification requirements during the monthly qualification cycle, the first dividend rate and annual percentage yield listed for this account in the Rate Schedule will apply if your balance is \$10,000.00 and below. The second dividend rate and annual percentage yield listed for this account in the Rate Schedule will apply if your balance is \$10,000.01 or greater. Each dividend rate will apply only to that portion of the account balance within each range. If you do not meet the minimum qualification requirements during the monthly qualification cycle, the third dividend rate and annual percentage yield will apply to the entire balance.

For High Yield Savings accounts, you may also increase your dividend if you have a Steady Saver or All in Bundle MyDesign Checking account. If you have a Steady Saver or All in Bundle MyDesign Checking account and meet the applicable minimum qualification requirements during the monthly qualification cycle, the first dividend rate and annual percentage yield listed for this account in the Rate Schedule will apply if your balance is \$25,000.00 and below. The second dividend rate and annual percentage yield listed for this account in the Rate Schedule will apply if your balance is \$25,000.01 or greater. Each dividend rate will apply only to that portion of the account balance within each range. If you do not meet the qualifications of the Steady Savers or All-In Bundle MyDesign Checking account, you will earn the dividend listed for this account

in the Rate Schedule on your balance up to \$10,000.00. The High-Yield Saving account is only available to open and service online, requires E-statements and is not available for service in-branch. This means service for the account is delivered through a mobile app or desktop computer. ATM access is not permitted, the account is limited to one withdrawal or transfer per month and is not available for overdraft transfers or automatic transfers to other accounts. Only one High-Yield Savings account is allowed per member.

**4. NATURE OF DIVIDENDS** — Dividends are paid from current income and available earnings after required transfers to reserves at the end of the dividend period.

**5. DIVIDEND COMPOUNDING AND CREDITING** — The compounding and crediting frequency of dividends and the dividend period applicable to each account are stated in the Rate Schedule. The dividend period is the period of time at the end of which an account earns dividend credit. The dividend period begins on the first calendar day of the period and ends on the last calendar day of the period. Dividends will be paid on the last day of the dividend period.

**6. ACCRUAL OF DIVIDENDS** — For all earning accounts, dividends will begin to accrue on noncash deposits (e.g. checks) on the business day you make the deposit to your account. For Savings, High-Yield Savings, Additional Savings, Money Market Savings, Platinum Money Market, Langley Saves, Holiday Savings, Money Market IRA, Platinum Checking, and MyDesign Savings accounts, if you close your account before accrued dividends are credited, you will not receive the accrued dividends.

**7. BALANCE INFORMATION** — To open any account, you must deposit or already have on deposit the minimum required share(s) in any account. Some accounts may have additional minimum opening deposit requirements. The minimum balance requirements applicable to each account are set forth in the Rate Schedule. For Savings, High-Yield Savings, Additional Savings, Money Market Savings, Platinum Money Market, Langley Saves, Holiday Savings, Money Market IRA, and Platinum Checking accounts, there is a minimum average daily balance required to earn the annual percentage yield disclosed for the dividend period. If the minimum average daily balance requirement is not met, you will not earn the annual percentage yield stated in the Rate Schedule. For accounts using the average daily balance method as stated in the Rate Schedule, dividends are calculated by applying a periodic rate to the average daily balance in the account for the dividend period. The average daily balance is calculated by adding the principal in the account for each day of the period and dividing that figure by the number of days in the

period.

**8. ACCOUNT LIMITATIONS** — For Platinum Money Market accounts, one free withdrawal or transfer per calendar month. A fee of \$25.00 will be charged for each additional withdrawal or transfer within the calendar month. One Platinum Money Market account is allowed per member and the account is not available for overdraft transfers. For Savings, Additional Savings, Money Market Savings, Platinum Money Market, Smart Checking, Platinum Checking, all MyDesign Checking options, Essential Checking, and Spend accounts, the maximum withdrawal amount of \$1,000.00 per day is permitted at an ATM. Members may have only one of the following MyDesign Checking account options: Steady Saver, Ride Rebate, Worry-Free, or All-In Bundle Checking. For all MyDesign checking options members must a) have the required primary checking account and b) be enrolled in e-statements. Only one Steady Saver Savings account is allowed per member. For Langley Saves, MyDesign Savings, and High Yield Savings accounts, ATM access is not permitted and this account is not available for overdraft transfers or automatic funds transfers to other accounts. Only one Langley Saves account is allowed per member. Electronic fund transfer activity is not permitted on the Money Market IRA account. For Money Market IRA accounts, the total amount you may contribute to an IRA for tax year 2024/2025 cannot exceed 100 percent of your earned income or \$7,000 for 2024 or \$7,500 for 2025 whichever is less. If you also maintain a Roth IRA, the maximum contribution to your Traditional IRA is reduced by any contributions you make to your Roth IRA. Your total annual contribution to all Traditional and Roth IRAs cannot exceed the lesser of the dollar amount described above or 100 percent of your earned income. Catch-Up Contribution. If you are age 50 or older by the close of the taxable year, you may make an additional contribution to your Traditional or Roth IRA of \$1,000 for the tax year 2024/2025. The Money Market IRA cannot be pledged, transferred or assigned to any party. For Langley Pays Checking accounts, the maximum withdrawal amount of \$1,000.00 per day is permitted at an ATM. Direct Deposit, E-statements and active online banking are required to open and maintain this account. For Essential Checking accounts, this account is only available to members within the limited-service area of Hampton Roads, MSA, Surry County, VA, Richmond-Petersburg, VA MSA and Raleigh-Durham-Chapel Hill, NC MSA.

**9. FEES FOR OVERDRAWING ACCOUNTS** — Fees for overdrawing your account may be imposed on each check, draft, item and one-time debit card transaction (if member has

consented to overdraft protection plan for one-time debit card transactions), preauthorized automatic debit, telephone-initiated withdrawal or any other electronic withdrawal or transfer transaction that is drawn on an insufficient available account balance. The entire balance in your account may not be available for withdrawal, transfer or paying a check, draft or item. You may consult the Membership and Account Agreement and Funds Availability Policy Disclosure for information regarding the availability of funds in your account. Fees for overdrawing your account may be imposed for each overdraft, regardless of whether we pay or return the draft, item or transaction. If we have approved an overdraft protection limit for your account, such fees may reduce your approved limit. Please refer to the Schedule of Fees and Charges for current fee information.

For one-time debit card transactions, you must consent to the Credit Union's overdraft protection plan in order for the transaction amount to be covered under the plan. Without your consent, the Credit Union may not authorize and pay an overdraft resulting from these types of transactions. Services and fees for overdrafts are shown in the document the credit union uses to capture the member's opt-in choice for overdraft protection and the Schedule of Fees and Charges.

**10. MEMBERSHIP** — As a condition of membership, you must purchase and maintain the minimum required share(s) as set forth below.
