

## OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER. ALL ENTRIES HAVE AN EQUAL CHANCE OF WINNING. ONE ENTRY PER PERSON. GIVEAWAY SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS. Offer valid while supplies last. Offer is only available in branch at the North Raleigh Langley Federal Credit Union. Open only to legal U.S. residents, 18 or older, who are not current members of Langley Federal Credit Union ("Eligible Person"). To enter, Eligible Persons must qualify and become part of Langley's membership base by, in part, deposit \$5 into a Langley share account. Business accounts are not valid. Void where prohibited or otherwise restricted by law. Taxes, if any, are each winner's sole responsibility. No transfer or assignment of prize is permitted. **GIVEAWAY PERIOD:** This Giveaway begins at 12:00:00 a.m. Eastern Time ("ET") on October 1, 2025, and ends at 11:59:59 p.m. ET on November 1, 2025 ("Giveaway Period"). The Giveaway consists of one entry per person and one drawing. Drawing will occur on November 3, 2025.

**HOW TO ENTER:** Eligible Persons will be automatically entered, once. To be eligible, members must become a Langley member and do one of the following: (1) enrolling in direct deposit (automatic paycheck deposit), (2) opening a new product/service, or (3) referring a Eligible Person using a Langley referral code ("Eligible Transaction"). Eligible Transactions must be completed in branch at the North Raleigh Langley Federal Credit Union located at 6308 Falls of Neuse Rd, Raleigh, NC 27615. Entries are limited to one per person during the Giveaway Period. The following are not Eligible Transactions: declined transactions, services, and products; incomplete referrals; and removal of direct deposit before the end of the Giveaway Period.

**DRAWINGS:** The drawing will be conducted on November 3, 2025, by Cynthia Jackson. The drawing will be at random. Winner need not be present to win but may be required to prove eligibility to receive a prize.

**PRIZE:** The prize will consist of two tickets to the NC State v. Florida State game, held on November 21, 2025. The prize is valued at \$250. Prize will be available for pick up at the North Raleigh Branch, 6308 Falls of Neuse Rd, Raleigh, NC 27615. The prize must be claimed within seventy-two (72) hours after the winner is announced on November 3, 2025. If winner is located outside the Raleigh area or unable to physically retrieve the prize, Langley may, in its sole determination, pick a runner up to claim the prize. Winners will receive a 1099-MISC Tax Form, if required, for the actual value of the prize to file with the IRS for the 2025 tax year.

**PRIZE RESTRICTIONS:** Prizes are not transferable. No substitution of prize permitted except at the sole discretion of Langley.

**PRIVACY AND PERSONAL INFORMATION:** Langley Federal Credit Union shall not sell, share or otherwise disclose personal information of entrants with third parties, other than to third parties engaged by Langley Federal Credit Union to fulfill the above purposes. In the event of any discrepancy between the privacy policy and these Official Rules, the privacy policy shall prevail.
